**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of December 20, 2022, by and between CASAMBA, LLC., a Delaware limited liability company (“**Grantor**”) and GOLUB CAPITAL MARKETS LLC, as administrative agent (in such capacity, “**Grantee**”), for the benefit of itself and other secured parties under that certain Trademark Security Agreement dated as of March 31, 2021 by and among the Grantor and the Grantee (as amended, the “**Trademark Security Agreement**”);

**WHEREAS**, pursuant to the terms and conditions of the Trademark Security Agreement, Grantor granted to Grantee on behalf of the secured parties a continuing security interest in and to, and lien on, all of Grantor’s right, title and interest in, to and under certain Trademark Collateral (as defined in the Trademark Security Agreement) including, without limitation, the Trademark Collateral set forth on Schedule A attached hereto (the “**Specified Trademarks**”);

**WHEREAS**, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office (“**USPTO**”) on March 31, 2021 at Reel/Frame 7239/0339 on March 31, 2021;


**WHEREAS**, Grantee desires to terminate and release all such security interests in and to, and liens on, the Specified Trademarks as herein provided;

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee on behalf of itself and the secured parties, hereby releases and terminates the liens granted in the Specified Trademarks under the Trademark Security Agreement, and the Security Agreement (as defined in the Trademark Security Agreement), and relinquishes unto Grantor the continuing security interest in, and lien on, the Specified Trademarks and otherwise assigns, grants and conveys to Grantor, without recourse, any and all right, title and interest the Grantee or the secured parties may have in, to or under the Specified Trademarks in order to revest in Grantor full and unencumbered title to said Specified Trademarks. Grantee hereby authorizes the Grantor’s or the Grantor’s designee, at the Grantor’s sole cost and expense, to record this Release with the USPTO.
