INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “**Agreement**”) is made and entered into on February 1, 2022 by and among Hexion Inc. (“**Hexion**”), Hexion Investments Inc. and Hexion Research Belgium SA (collectively, the “**Assignors**”), and Westlake Olefins LLC (“**Assignee**”) (Assignors and Assignee are each hereinafter referred to as a “**Party**,” and collectively, as the “**Parties**”). Capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Purchase Agreement (as defined below).

WHEREAS, Hexion, Assignee and, solely for the purposes of Section 13.13 thereof, Westlake Chemical Corporation (together, “**Buyer**”) are parties to that certain Stock Purchase Agreement, dated as of November 24, 2021 (the “**Purchase Agreement**”), and, upon the terms and subject to the conditions set forth therein, Hexion has agreed to sell, convey, transfer and assign (or cause to be sold, conveyed, transferred and assigned) to Buyer, and Buyer has agreed to purchase from Hexion and its Retained Subsidiaries (as defined in the Purchase Agreement), all of its and their right, title and interest in, to and under the Purchased Assets (as defined in the Purchase Agreement), including the Owned Business Intellectual Property Rights listed on Attachment A (the “**Assigned IP Assets**”); and

WHEREAS, Assignors wish to sell, convey, transfer and assign to Assignee all of such right, title and interest in, to and under the Assigned IP Assets, and Assignee wishes to purchase, acquire and accept all of Assignors’ right, title and interest in, to and under the Assigned IP Assets.

NOW, THEREFORE, in consideration of the mutual promises set forth in this Agreement and the Purchase Agreement and other good and valuable consideration, the adequacy and receipt of which are hereby acknowledged, the Parties hereby agree as follows:

1. Transfer of Assigned IP Assets. Assignors do hereby sell, convey, transfer and assign to Assignee, and Assignee does hereby purchase, acquire and accept, all of Assignors’ right, title and interest in, to and under the Assigned IP Assets, together with all goodwill appurtenant to any Trademarks included in the Assigned IP Assets and all common law rights in any such Trademarks, all registrations and applications that have been or may be granted for the Assigned IP Assets, the right to claim priority to any of the Assigned IP Assets and all rights to sue or recover and retain damages, other compensation and costs and attorneys’ fees, and obtain any other legal and equitable remedies, for past, present and future infringement or misappropriation of the Assigned IP Assets.

2. Subject to Purchase Agreement. This Agreement is being executed and delivered pursuant to, and is subject to and shall be governed by the terms and conditions of, the Purchase Agreement. Nothing in this Agreement is intended to or shall be deemed to amend, modify, supplement, or limit in any manner any of the representations, warranties, covenants, agreements, rights, or obligations of Hexion and Buyer under the Purchase Agreement. In the event of any conflict between the terms and conditions of this Agreement and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall control.

3. Authorization. Assignors do hereby authorize and request the Commissioners for Patents and Trademarks, and the corresponding entity or agency in any applicable foreign country, to record Assignee as assignee and owner of the entire right, title and interest in, to and under the issued patents, pending patent applications and Trademarks included in the Assigned IP Assets.


4. Further Assurances. Assignors agree to sign all necessary papers and perform all lawful acts reasonably requested to give effect to and record the assignment to Assignee under this Agreement, without further compensation, but at the sole cost and expense of Assignee or its successors and assigns.

5. Miscellaneous. This Agreement shall be governed by and construed in accordance with the law of the State of Delaware, without regard to the conflicts of law rules of such state. The parties hereto agree that any Action seeking to enforce any provision of, or based on any matter arising out of or in connection with, this Agreement or the transactions contemplated hereby shall be brought in the Delaware Court of Chancery and any state appellate court therefrom within the State of Delaware (or, only if the Delaware Court of Chancery declines to accept jurisdiction over a particular matter, any federal court within the State of Delaware), so long as one of such courts shall have subject matter jurisdiction over such Action, and that any cause of action arising out of this Agreement shall be deemed to have arisen from a transaction of business in the State of Delaware, and each of the parties hereby irrevocably consents to the jurisdiction of such courts (and of the appropriate appellate courts therefrom) in any such Action and irrevocably waives, to the fullest extent permitted by law, any objection that it may now or hereafter have to the laying of the venue of any such Action in any such court or that any such Action brought in any such court has been brought in an inconvenient forum. Process in any such Action may be served on any party anywhere in the world, whether within or without the jurisdiction of any such court. Without limiting the foregoing, each party agrees that service of process on such party as provided in Section 13.01 of the Purchase Agreement shall be deemed effective service of process on such party. This Agreement will be binding on and inure to the benefit of the parties and their respective successors and permitted assigns. This Agreement may not be changed, modified, discharged or terminated orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns. This Agreement may be signed in any number of counterparts (including by .pdf file exchanged via email or other electronic transmission), each of which is and shall be deemed an original and all of which taken together shall constitute one and the same instrument. Sections 13.08, 13.09, 13.10, 13.11, and 13.12 of the Purchase Agreement shall apply, mutatis mutandis.
