TRADEMARK ASSIGNMENT

This Trademark Assignment is effective as of October 3, 2022 (the "Effective Date") by and among BPA Distribution Group, LLC, a Florida limited liability company ("the Assignee") and Accent Building Materials Holdings, LLC, a Delaware limited liability company, with its principal address at 10131 FM 2920 Road, Tomball, Texas 77375 (the "Assignee").

WHEREAS the Assignor owns the CAT-5 Logo trademark and all applications therefor (including U.S. Application Serial No. 97194784) ("the Application"), together with the goodwill of the business associated therewith (collectively, the "Mark");

WHEREAS Assignee is the owner of Accent Building Materials, Inc. ("ABM") and ABM is the owner of Assignor;

WHEREAS Assignee is the owner of all other intellectual property used by Assignee and its subsidiaries and Assignor and Assignee desire to assign the Mark and the Application from Assignor to Assignee so that Assignee may oversee the use of such Mark and record the change in ownership of the Registration with the United States Patent & Trademark Office;

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Assignee all of Assignor's right, title, and interest throughout the world of whatever kind in any jurisdiction in and to the Mark and the Application, together with all goodwill of the business relating to the goods with which the Mark is used and covered by the Application.
2. Assignor authorizes the Commissioner of Trademarks of the United States to record the transfer of the Application to Assignee as assignee of Assignor's entire right, title and interest therein.
3. Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Mark and the Application in the United States or in foreign trademark offices where applications related to the Mark or the Application may be filed.
4. This Assignment is binding on the heirs, assigns, representatives and successors of the undersigned and extends to the successors, assigns and nominees of the Assignee.
5. This Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each
