**NOTICE OF TRADEMARK SECURITY AGREEMENT  
(FOR RECORDATION PURPOSES)**

This Notice of Trademark Security Agreement, dated as of February 21, 2023, is made with regard to ALWIN MANUFACTURING COMPANY, INC., a Wisconsin corporation ("AMC"), ALL PRODUCTS LLC, a Wisconsin limited liability company ("All Products"), and PALMER FIXTURE COMPANY, LLC, a Wisconsin limited liability company (collectively with AMC and All Products, the "Borrowers"), each having an address for notice at 3061 S Ridge Road, Suite 101, Green Bay, Wisconsin 54304, and FIRST BUSINESS SPECIALTY FINANCE, LLC, a Wisconsin limited liability company ("Lender"), having an address for notice at 401 Charmany Drive, Madison WI 53719.

**RECITALS:**
