NOTICE OF PARTIAL RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of January 31, 2023 is made by Credit Suisse AG, Cayman Islands Branch, in its capacity as collateral agent (referred to herein as the “Agent”), in favor of Intrado Life & Safety, Inc. (f/k/a West Safety Services, Inc.), a Delaware Corporation (the “Company”).

W I T N E S S E T H:

WHEREAS, the Company, Intrado Corporation (f/k/a West Corporation) (“Intrado”), the Agent and certain other parties entered into that certain Collateral Agreement (First Lien), dated as of October 10, 2017 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, Intrado executed and delivered to the Agent a Notice of Grant of Security Interest in Trademarks, dated October 10, 2017, which was recorded in the United States Patent and Trademark Office (the “USPTO”) on October 10, 2017 at Reel/Frame No. 6179/0268 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Intrado assigned and pledged to the Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a continuing security interest (the “Security Interest”) in all of its right, title and interest in, to and under the Trademark Collateral;

WHEREAS the Trademark Collateral included the Trademarks listed on Schedule A (the “Released Trademarks”), which were assigned by Intrado to the Company pursuant to that certain Trademark Assignment Agreement, dated as of December 29, 2022, by and between Intrado and the Company; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, all capitalized terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Trademark Security Agreement.

SECTION 2. Release of Security Interest. The Agent, without recourse, representation or warranty, does hereby release, reassign, relinquish and discharge its Security Interest in the Released Trademarks and assigns, transfers and conveys to the Company any and all of its rights, title and interests in the Released Trademarks. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the Security Interest held by the Agent in the Trademark Collateral.


SECTION 3. Authorization to Record; Further Assurances. The Agent hereby authorizes the Company or the Company's authorized representative to record this Release with the USPTO and otherwise record or file this Release in any other applicable governmental office or agency. The Agent agrees to execute and deliver to the Company any further documents and instruments and do any further acts which the Company (or its agents or designees) reasonably request (at the Company's sole cost and expense) as needed to further achieve the purposes of this Release

SECTION 4. Choice of Law. THIS RELEASE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSES OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO ANY PRINCIPLE OF CONFLICTS OF LAW THAT COULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
