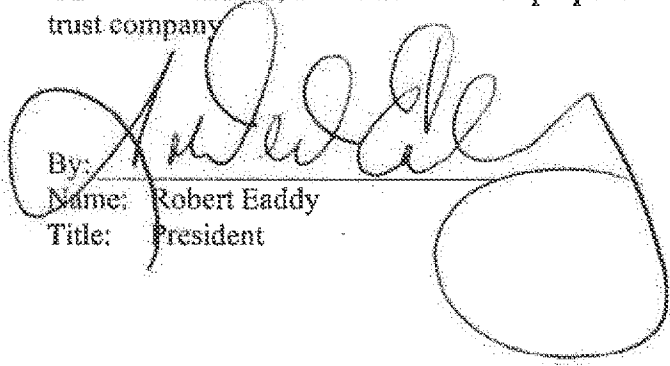
**SIXTH:** A copy of the executed Agreement will be furnished by BMTCDE, on request and without cost, to any stockholder of the Constituent Companies.
