**TERMINATION AND RELEASE
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the “Release”) is executed as of December 9, 2022, by MIDCAP FUNDING IV TRUST, a Delaware statutory trust, as successor in interest to MidCap Funding X Trust (“Agent”) in favor of LUX GLOBAL LABEL COMPANY, LLC (“Grantor”). Unless otherwise indicated, capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Security Agreement as referred to below.

WHEREAS, the Grantor and the Agent executed a certain Intellectual Property Security Agreement dated as of June 15, 2018 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”) pursuant to which the Grantor granted to the Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (as defined therein) (the “Security Interest”), including, without limitation, the Patents listed on Exhibit A hereto, and the Trademarks listed on Exhibit B hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on June 19, 2018, at Reel 046125 and Frame 0010 with respect to the Patents listed on Exhibit A hereto;

WHEREAS, the Security Agreement was recorded with the USPTO on June 19, 2018, at Reel 6356 and Frame 0699 with respect to the Trademarks listed on Exhibit B hereto; and

WHEREAS, the Agent has agreed to release, and terminate its Security Interest in, the Intellectual Property Collateral and assign and transfer to the Grantor all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to the Grantor the entire right, title and interest to the Intellectual Property Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Agent hereby releases and terminates the Security Agreement and assign and transfers to the Grantor, without representation, warranty or recourse, all of the Agent’s right, title and interest in and to the Intellectual Property Collateral (including, without limitation, the Patents and Patent Applications listed on Exhibit A hereto, and the Trademarks listed on Exhibit B hereto), effective as of the date set forth above.


