**TRADEMARK SECURITY AGREEMENT**

**(Trademark Registrations and Trademark Applications)**

TRADEMARK SECURITY AGREEMENT, dated as of February 22, 2023, between NCL US IP CO 2, LLC, a Delaware limited liability company (the “Grantor”), and U.S. Bank Trust Company, National Association, as Security Agent.

WHEREAS, Grantor owns the Trademark Collateral (as defined below);

WHEREAS, NCL CORPORATION LTD., an exempted company incorporated under the laws of Bermuda (the “Issuer”), the Guarantors (as defined therein) and U.S. Bank Trust Company, National Association, as trustee and as security agent, are parties to a Indenture, dated as of February 22, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the “Indenture”); and

WHEREAS, pursuant to (i) a Collateral Agreement dated as of February 22, 2023 (as amended and/or supplemented from time to time, the “Collateral Agreement”) among the Grantors identified therein and the Security Agent for the Secured Parties referred to therein (in such capacity, together with its successors in such capacity, the “Grantee”) and (ii) certain other Security Documents (including this Trademark Security Agreement), Grantor has granted to Grantee for the benefit of such Secured Parties a continuing security interest in personal property of Grantor, including all right, title and interest of Grantor in, to and under the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to and upon the terms and conditions contained in the Collateral Agreement, Grantor hereby grants to Grantee, to secure the Note Obligations, a continuing security interest in all of Grantor’s right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “Trademark Collateral”), whether now owned or existing or hereafter acquired or arising:

(i) each Trademark (excluding any Excluded Assets), including, without limitation, each Trademark registration or application therefor referred to in Schedule 1 hereto; and

(ii) all proceeds of, revenues from, and accounts and general intangibles arising out of, the foregoing, including, without limitation, all proceeds of and revenues from any claim by Grantor against third parties for past, present or future infringement or unfair competition regarding the same of any Trademark (including, without limitation, any Trademark owned by Grantor and identified in Schedule 1).

Grantor irrevocably constitutes and appoints Grantee and any officer or agent thereof, with full power of substitution, as its true and lawful attorney in fact with full power and authority in the name of Grantor or in Grantee’s name, from time to time, in Grantee’s discretion, so long as any Event of Default shall have occurred and be continuing, to take with respect to the Trademark Collateral any and all appropriate action which Grantor might take with respect to the Trademark Collateral and to execute any and all documents and instruments which may be necessary or

desirable to carry out the terms of this Trademark Security Agreement and to accomplish the purposes hereof.


Except to the extent not prohibited by the Collateral Agreement or the Indenture, Grantor agrees not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the Trademark Collateral.

THIS TRADEMARK SECURITY AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO THE CONFLICT OF LAWS PRINCIPLES THEREOF.

The foregoing security interest is granted in conjunction with the security interests granted by Grantor to Grantee pursuant to the Collateral Agreement. Terms defined in the Collateral Agreement (or whose definitions are incorporated by reference in Section 1 of the Collateral Agreement) and not otherwise defined herein have, as used herein, the respective meanings provided for therein. Grantor acknowledges and affirms that the rights and remedies of Grantee with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Collateral Agreement, the Collateral Agreement shall govern.
