RATIFICATION AND AMENDMENT OF TRADEMARK SECURITY AGREEMENT

This Ratification and Amendment of Trademark Security Agreement is made as of February 22, 2023 (this "Ratification") by and between SEA DELIGHT LLC, a Florida limited liability company ("Borrower"), and TD BANK, N.A., a national banking association ("Lender").

BACKGROUND

Reference is made to a certain Grant of Security Interest in United States Trademarks (the "Trademark Agreement") dated as of December 20, 2019 made by and between Borrower and Lender. Pursuant to the terms of the Trademark Agreement, Borrower granted Lender a security interest in and to certain collateral, as security for the payment and performance of all obligations and indebtedness of the Borrower to Lender under that certain Amended and Restated Loan and Security Agreement, dated as of December 20, 2019, as amended by First Amendment to Loan and Security Agreement, dated on or about April 7, 2020, and as further as amended by Second Amendment to Loan and Security Agreement, dated on or about September 11, 2020 (hereinafter, the "Existing Loan Agreement").

On this date, Borrower, Lender and others have entered into that certain Third Amendment to Loan and Security Agreement (the "Third Amendment"), which amends the Existing Loan Agreement (such Existing Loan Agreement, as amended by the Third Amendment, the "Loan Agreement"). Borrower and Lender wish to (i) confirm and reaffirm that the Trademark Agreement shall continue to secure, *inter alia*, all obligations and indebtedness of Borrower to Lender under the Loan Agreement, and (ii) supplement Schedule A of the Trademark Agreement to include new trademarks held by the Borrower.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Borrower and Lender hereby covenant and agree as follows:


1. Subject to #2 below, Borrower hereby ratifies, confirms and reaffirms, all and singular, the terms and conditions of the Trademark Agreement. Without limiting the foregoing, Borrower further ratifies, confirms and reaffirms that the obligations secured by the Trademark Agreement include, without limitation, all of the Obligations under, and as defined in, the Loan Agreement.
2. Schedule A to the Trademark Agreement is hereby supplemented, but not replaced, with Schedule A-1 annexed hereto.
3. Borrower hereby confirms and reaffirms each of the representations and warranties set forth in the Trademark Agreement are true and accurate in all respects as of the date hereof.
