**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of February 22, 2023 (this “Release”), is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the “Administrative Agent” or the “Grantee”) under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement or the Security Agreement (as defined below), as applicable).

**WHEREAS**, in connection with that certain Amended and Restated Credit Agreement, dated as of December 5, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Almost Family, Inc. (the “Borrower”), the Lenders from time to time party thereto and the Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrower;

**WHEREAS**, the Borrower and certain Subsidiaries of the Borrower (the “Grantors” and each, a “Grantor”) entered into that certain Amended and Restated Pledge and Security Agreement, dated as of December 5, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), in favor of the Administrative Agent;

**WHEREAS**, in connection with the Credit Agreement and pursuant to the Security Agreement and those certain agreements described on Annex I attached hereto (collectively, the “IP Security Agreements”), the Grantors granted security interests to the Administrative Agent in certain intellectual property described in Annex I (the “IP Collateral”); and

**WHEREAS**, the IP Security Agreements were recorded in the United States Patent and Trademark Office on the dates and on the reels/frames set forth on Annex I attached hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the party hereto agrees as follows:


1. ***Release of Security Interest.*** The Administrative Agent hereby irrevocably **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in the IP Collateral, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to the relevant Grantor.

2. ***Governing Law.*** This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
