

#### TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of February 22, 2023 ("<u>Release</u>"), is made by Route 2 Capital Partners SBIC, L.P. ("<u>Investor</u>") in favor of Axim Geospatial, LLC f/k/a Continental Mapping Consultants, LLC, Continental Mapping Acquisition Corp., TSG Solutions, Inc., Delphi Research, Inc., Geographic Information Services, Inc., Geopiphany, LLC, and GISIP, LLC (each a "<u>Grantor</u>" and collectively, the "<u>Grantors</u>").

WHEREAS, Grantors and Investor are parties to that certain Investment Agreement dated as of January 29, 2021 (as amended, modified, extended or restated from time to time, the "<u>Investment</u> Agreement");

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of January 29, 2021, recorded with (i) the Trademark Division of the United States Patent and Trademark Office (the "<u>USPTO</u>") at Reel 7173, Frame 0823 and (ii) the Patent Division of the USPTO at Reel 055082, Frame 0022, and (iii) the U.S. Copyright Office (the "<u>USCO</u>") in Volume 9976, Document No. 301 (i.e., V9976D301) (as amended, modified, extended or restated from time to time, the "<u>Security Agreement</u>") by and among the Grantors and Investor, each Grantor granted to the Investor a continuing security interest in all of the Grantor's right, title and interest in, to and under Collateral (as that term is defined in the Security Agreement); and

WHEREAS, pursuant to that certain Grant of Intellectual Property Security Interest dated as of January 29, 2021, by and among the Grantors and Investor (as amended, modified, extended or restated from time to time, the "Grant"), each Grantor granted to the Investor a continuing security interest in all of the Grantor's right, title, and interest in, to and under Intellectual Property Collateral (as that term is defined in the Grant).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Investor hereby agrees as follows:

**SECTION 1**. <u>Defined Terms</u>. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in Investment Agreement and the Security Agreement.

#### **SECTION 2**. Termination and Release. Investor hereby:

- (a) terminates, cancels, discharges, and releases the continuing security interest in all of the Grantors' right, title and interest in, to and under the Collateral and the Intellectual Property Collateral, including, but not limited to, the foregoing listed on <u>Schedule 1</u> attached hereto and further including any goodwill associated with any of the foregoing, granted in favor of Investor pursuant to the Security Agreement or the Grant and any right, title or interest of the Investor in the Collateral and Intellectual Property Collateral shall hereby cease and become void;
- (b) if and to the extent that the Investor has acquired any right, title or interest in and to the Collateral or the Intellectual Property Collateral under the Security Agreement or Grant, re-transfers, reconveys and re-assigns such right, title or interest to the applicable Grantor;
  - (c) terminates the Security Agreement and the Grant; and
- (d) authorizes the recordation of this Release with the United States Copyright Office and the United States Trademark and Patent Office at Grantors' expense.

**SECTION 3**. Choice of Law. This Release shall be governed by and construed and interpreted in accordance with, the laws of the State of New York, without regard to any conflict of laws principles.

**SECTION 4**. <u>Further Assurances</u>. The Investor hereby agrees to take such further action as the Grantor may reasonably request from time to time to the extent necessary in order to effectuate the termination and release of the security interest contemplated by this Release, all without recourse or any representation or warranty of any kind and all at the expense of the Grantor.
