RELEASE OF TRADEMARK SECURITY AGREEMENT

February 23, 2023

This RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”), dated as of the date set forth above, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacities as administrative agent and collateral agent for the Secured Parties (in such capacities, the “Releasor”), in favor of C-A-L Ranch Stores, LLC (f/k/a C-A-L Stores Companies, Inc.) (the “Releasee”)

WHEREAS, pursuant to that certain Security Agreement, dated as of August 24, 2022 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by the Releasee and the other parties thereto in favor of the Releasor, the Releasee granted to the Releasor a security interest in certain collateral, including the Intellectual Property Collateral (as defined in the Security Agreement);

WHEREAS, pursuant to the Security Agreement, the Releasee executed and delivered that certain Trademark Security Agreement, dated as of August 24, 2022 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office at Reel 7831, Frame 0110 on August 24, 2022; and

WHEREAS, the Releasee has requested and the Releasor has agreed to provide this Release to confirm the termination, release, relinquishment and discharge of its security interest in the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable.

2. Release of Security Interest. The Releasor hereby (i) terminates, releases, relinquishes and discharges its security interest in the Intellectual Property Collateral, including without limitation, all of the Releasee’s right, title and interest in and to the Trademarks listed on Schedule 1 hereto, and (ii) reassigns, transfers and conveys to the Releasee any right, title and interest of the Releasor in the Intellectual Property Collateral, in each case, without recourse or representation or warranty, express or implied, of any kind.

3. Termination. The Releasor, without recourse or representation or warranty, express or implied, of any kind, terminates and cancels the Trademark Security Agreement.

4. Authorization. The Releasor hereby authorizes the Releasee or Releasee’s agent to record this Release with the United States Patent and Trademark Office.

5. Further Assurances. The Releasor agrees to take all further actions, and provide to the Releasee and its successors, assigns or other legal representatives, all such cooperation and


assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Releasee at the Releasee's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

6. Governing Law. This Release shall be governed exclusively under the laws of New York.


