## RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

THIS RELEASE dated as of February 16, 2023 (this “*Release*”) is made by Trinity Capital Inc., a Maryland corporation (the “*Secured Party*”), under the Intellectual Property Security Agreement dated as of April 23, 2020 (as amended, restated or otherwise modified from time to time, the “*Security Agreement*”) by and between the Secured Party and Madison Reed, Inc., a Delaware corporation (the “*Debtor*”) and recorded in the records of the United States Patent and Trademark Office at Reel/Frame No. 6922/0478 and Reel/Frame No. 052491/0146.

WHEREAS, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtor’s trademarks, including but not limited to the trademarks listed on attached Schedule A (the “*Trademarks*”), and the Debtor’s patents, including but not limited to the patents listed on attached Schedule B (the “*Patents*”).

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks and the Patents; (ii) restore all right, title and interest in and to the Trademarks and the Patents to Debtor; and (iii) terminate any and all liens and encumbrances respecting the Trademarks and the Patents under the Security Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks and the Patents, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks and the Patents under the Security Agreement. Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Debtor’s expense, as may be reasonably necessary to effect the release of the security interest in the Trademarks and the Patents contemplated hereby.
