**TERMINATION OF TRADEMARK SECURITY AGREEMENT**

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT**, dated as of February 28, 2023, is made by Wilmington Trust, National Association, in its capacity as the collateral trustee (in such capacity, the “Collateral Trustee”) under that certain Pledge and Security Agreement, dated as of December 27, 2017 by and among Par Petroleum, LLC, a Delaware limited liability company, Par Petroleum Finance Corp., a Delaware corporation, each other grantor party thereto (including the Grantor (as defined below)) and the Collateral Trustee.

**WHEREAS**, each of Mid Pac Petroleum, LLC (together with its successors and assigns, the “Grantor”) has granted a security interest in certain property to the Collateral Trustee, including without limitation a security interest in certain trademarks (“Trademarks”);

**WHEREAS**, the security interest in the Grantor’s Trademarks granted to the Collateral Trustee was recorded at the United States Patent and Trademark Office on December 21, 2017 at Reel/Frame 6255/0916; and


**WHEREAS**, the Collateral Trustee has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, the Collateral Trustee hereby terminates and releases all mortgages, liens, and security interests granted to the Collateral Trustee in all of the Grantor’s Trademarks to which the Grantor is a party including the Trademarks identified on Schedule A.


