**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of February 28, 2023, by **TORONTO DOMINION (TEXAS) LLC**, a Texas limited liability company (“Collateral Agent”) in favor of **ZCOLO, LLC**, a Delaware limited liability company with an address at 400 South Akard Suite 100, Dallas, Texas 75202 (“Pledgor”).

W I T N E S S E T H:

WHEREAS, the Pledgor entered into a certain first lien trademark security agreement dated December 14, 2020 (the “Trademark Security Agreement”) with Collateral Agent, notice of which recorded on December 14, 2020 at the United States Patent and Trademark Office at Reel 7133, Frame 0481.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Pledgor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title and interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed in **Schedule 1**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its interest in the Trademark Collateral of the Pledgor, including all Goodwill associated with the Trademarks, and assigns, transfers and conveys to Pledgor (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) the Security Interest in such Trademark Collateral.
