**NOTICE OF RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Notice of Release”), effective as of 3/14/2022, is made by REDMONT PRIVATE DEBT FUND III, L.P., a Delaware Limited Partnership (“Redmont”). Unless otherwise expressly indicated, all capitalized terms used, but not defined, in this Notice of Release have the meanings indicated in the Trademark Security Agreement (as defined below).

WHEREAS, Redmont made that certain Trademark Security Agreement (the “Trademark Security Agreement”), effective as of May 5, 2021, which was recorded at the United States Patent and Trademark Office (“USPTO”) on May 6, 2021 at Reel 7292, Frame 0052, whereby FITJOY NUTRITION, LLC (“Fitjoy”) granted to Redmont, a security interest in the trademarks listed on Schedule A attached hereto; and

WHEREAS, Redmont has released the Trademark Security Agreement and the security interests and liens on the Trademark Collateral granted to Redmont pursuant thereto.

NOW, THEREFORE, Redmont hereby agrees as follows:

1. **Release of Security Interest.** For valuable consideration, Redmont hereby terminates, discharges and releases the Trademark Security Agreement and any and all mortgages, liens and security interests in the Trademark Collateral granted to Redmont pursuant to the Trademark Security Agreement, in each case without representation, warranty or recourse of any kind, and any right, title or interest of Redmont in such Trademark Collateral pursuant to the Trademark Security Agreement shall hereby cease and become void.

2. **Authorization.** Redmont authorizes this Notice of Release to be recorded with the USPTO and any other domestic and foreign agencies or offices.
