

INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of February 22, 2023, (this "Agreement"), by Mazooma Technical Services, Inc., an Ontario corporation, JS Innovations LLC, a Washington limited liability company, Nuvei Technologies Corp., a corporation constituted in accordance with the laws of Canada, Nuvei Corporation, a corporation constituted in accordance with the laws of Canada, Nuvei Commerce, LLC (f/k/a Base Commerce Acquisition Company, LLC), a Delaware limited liability company, Paya, Inc., a Delaware corporation, Direct Connect Merchant Services, LLC, a Florida limited liability company, and First Mobile Trust, LLC, an Ohio limited liability company, (each, a "Grantor") in favor of Bank of Montreal, as administrative agent and collateral agent (in such capacities, the "Administrative Agent") for the Secured Parties.

Reference is made to that certain Pledge and Security Agreement, dated as of February 22, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the "Grantors" party thereto and the Administrative Agent. The Lenders (as defined below) have extended credit to the Borrowers (as defined in Credit Agreement (as defined below)) subject to the terms and conditions set forth in that certain Credit Agreement, dated as of February 22, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among, *inter alios*, Nuvei Technologies Corp., a corporation constituted in accordance with the laws of Canada ("Canadian Borrower"), Pivotal Refi LP, a Delaware limited partnership ("Refi LP"), Nuvei Technologies Inc., a Delaware corporation ("NTI" and together with Refi LP, collectively, the "U.S. Borrowers"; U.S. Borrowers, together with Canadian Borrower, the "Borrowers"), Canadian Borrower, as the Borrower Representative, Nuvei Corporation, a corporation constituted in accordance with the laws of Canada ("Holdings"), the other Loan Parties party thereto, the lenders from time to time party thereto and the Administrative Agent. Consistent with the requirements set forth in Sections 4.01 and 5.12 of the Credit Agreement and Section 4.03(c) of the Security Agreement, the parties hereto agree as follows:

SECTION 1. *Terms*. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement.

SECTION 2. *Grant of Security Interest*. As security for the prompt and complete payment or performance, as the case may be, in full of the Secured Obligations, each Grantor, pursuant to the Security Agreement, did and hereby does pledge, mortgage, transfer and grant to the Administrative Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in all of its right, title or interest in, to or under all of the following assets, whether now owned or at any time hereafter acquired by or arising in favor of such Grantor and regardless of where located (collectively, the "IP Collateral"):

- A. all Trademarks, including the Trademark registrations and registration applications in the United States Patent and Trademark Office listed on <u>Schedule I</u> hereto;
- B. all Patents, including the Patent registrations and pending applications in the United States Patent and Trademark Office listed on <u>Schedule II</u> hereto;
- C. the Copyright registrations and pending applications for registration in the United States Copyright Office listed on <u>Schedule III</u>; and
 - D. all proceeds of the foregoing;

in each case to the extent the foregoing items constitute Collateral.

SECTION 3. Security Agreement. The security interests granted to the Administrative Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Administrative Agent pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the IP Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. *Governing Law*. This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
