This assignment includes all rights of action, powers and benefits in, of and to the IPR, due or accrued, including the right to sue for and recover, in Assignee's own name and that of its successors, assigns and other legal representatives, all remedies of every nature (including without limitation injunctive relief, damages, profits, costs and attorney fees) arising out of past infringement, misappropriation or dilution of the IPR or injury to the related goodwill.

Assignor agrees to do all acts and execute all documents, and to ensure that its officers, employees and agents do all acts and execute all documents, necessary to secure Assignee's or its designee's ownership of the IPR transferred under this Assignment of Intellectual Property Rights. Assignor irrevocably appoints each of the directors of Assignee from time to time severally as that Assignor's attorney to do all acts and execute all documents which the Assignor is obliged to do or execute by this clause.

This Assignment of Intellectual Property Rights and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of the Commonwealth of Australia and the States and Territories thereof.

If any term or provision of this Assignment of Intellectual Property Rights shall to any extent be invalid or unenforceable, the remaining terms shall not be affected thereby and each term and provision of the assignment shall be valid and enforced to the fullest extent permitted by law.
