

3. Binding Effect. This Assignment is binding upon and will inure to the benefit of the parties hereto and their respective heirs, successors, and assigns.


4. Governing Law. This Assignment shall be construed and interpreted according to the laws of the State of Alabama, without reference to its conflicts of law provisions.
