RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of February 27, 2023 (the “Release”), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as administrative agent and as collateral agent for the Secured Parties (together with its successors and assigns in such capacity, the “Collateral Agent”), in favor of HYPER MANIA LTD., a limited company incorporated under the laws of Israel, and Jelly Button Games Ltd., a limited company incorporated under the laws of Israel (each a “Pledgor” and collectively, the “Pledgors”). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Credit Agreement (as defined below).

WITNESSETH

WHEREAS, Playtika Holding Corp., a Delaware corporation, Credit Suisse AG, Cayman Islands Branch, as administrative agent, the Collateral Agent and the lenders party thereto from time to time, entered into that certain Credit Agreement, dated as of December 10, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, pursuant to the Credit Agreement and the Foreign Collateral Agreements (as defined in the 2019 Agreement), the Pledgors executed the Intellectual Property Security Agreement, dated as of December 10, 2019 (the “2019 Agreement”) and recorded with the U.S. Patent and Trademark Office on January 21, 2020, at Reel/Frame No. 6841/0770 and filed with the U.S. Copyright Office on December 11, 2019, at Volume 9972, Document No. 640, pursuant to which the Pledgors granted to the Collateral Agent, for the benefit of the Secured Parties, a floating charge security interest in all of the Pledgors’ right, title and interest in or to any and all of the IP Collateral (as defined in the 2019 Agreement), including the copyright and trademarks listed on Schedule I hereto (the “2019 Specified IP Collateral”); and

WHEREAS, pursuant to the Credit Agreement and the Foreign Collateral Agreements (as defined in the 2021 Agreement), the Pledgors executed the Intellectual Property Security Agreement, dated as of March 11, 2021 (the “2021 Agreement”) and recorded with the U.S. Patent and Trademark Office on March 29, 2021 at Reel/Frame No. 7235/0843 and filed with the U.S. Copyright Office on March 29, 2021, at Volume 15001, Document No. 543, pursuant to which the Pledgors granted to the Collateral Agent, for the benefit of the Secured Parties, a floating charge security interest in all of the Pledgors’ right, title and interest in or to any and all of the IP Collateral (as defined in the 2021 Agreement), including the copyright and trademarks listed on Schedule II hereto (the “2021 Specified IP Collateral” and, together with the 2019 Specified IP Collateral, the “Specified IP Collateral”); and


WHEREAS, the Pledgors have requested that the Collateral Agent, and the Collateral Agent has agreed to, evidence the release of its floating charge security interest in all right, title and interest in or to the Specified IP Collateral in connection with the release of the Pledgors from their obligations under the Foreign Collateral Agreements.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent, without recourse, representation or warranty, hereby acknowledges the discharge, termination and release of its floating charge security interest in all right, title and interest in or to the Specified IP Collateral, and agrees that all the floating charge security interest in the Specified IP Collateral has been discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Specified IP Collateral under the Foreign Collateral Agreements, the 2019 Agreement and the 2021 Agreement, and authorizes and requests that this Release be recorded with the United States Patent and Trademark Office and the U.S. Copyright Office.


