TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of **December 31, 2022** (the "Effective Date") by and between Garnet Wine Company, LLC, a California limited liability company, having an address at 6342 Bystrum Road, Ceres, CA 95307 ("Assignor") and Bronco Wine Company, a California corporation, having an address at 6342 Bystrum Road, Ceres, CA 95307 ("Assignee").

Whereas, Assignor and Assignee are parties to that certain Intellectual Property Purchase and Assignment Agreement (the "Purchase Agreement") pursuant to which Assignor has agreed to sell to Assignee the trademark "GARNET" for "wine" which was registered with the United States Patent and Trademark Office on December 24, 1991 as Registration Number 1669670 (the "Garnet Mark").

Now, therefore, pursuant to the terms of the Purchase Agreement, Assignor, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby assigns and transfers to Assignee, and Assignee hereby accepts:

A. All rights, title and interest held by Assignor in and to the Garnet Mark, the associated goodwill and the registration for the Garnet Mark; and

B. All rights to damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement of the Garnet Mark or injury to said goodwill, together with the right to sue and recover the same.

This Trademark Assignment shall be construed, performed and enforced in accordance, and governed by, the laws of the State of California, without giving effect to the principles of conflicts of laws thereof.

In the event that any of the provisions of this Trademark Assignment shall be construed to conflict with a provision of the Purchase Agreement, the provisions in the Purchase Agreement shall be deemed controlling.
