Trademark Assignment

RECITALS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

ASSIGNMENT

1. KSL hereby sells, transfers, assigns, and delivers to Omni, as of the Effective Date, the entire right, title, and interest in and to the Trademarks and the goodwill associated therewith.
2. KSL also sells, transfers, assigns, and delivers to Omni all income, royalties, or payments due or payable as of the Effective Date or thereafter, including all claims for damages by reason of past, present, or future infringement or other unauthorized use.
3. KSL hereby covenants that KSL has full right to convey the entire interest herein assigned, and that KSL has not executed, and will not execute, any agreements in conflict therewith.
