**TRADEMARK ASSIGNMENT AGREEMENT**

This agreement (this "Agreement") is by and between 22squared, inc., a Georgia corporation ("Assignor"), and GBG Trade School, LLC dba Trade School ("Assignee"), a Georgia limited liability company. Effective as of May 27, 2020, Assignor and Assignee (collectively the "Parties") agree as follows:
