**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 28, 2023 (this “*Termination and Release*”), is made by Perceptive Credit Holdings III, LP, as Administrative Agent (in such capacity, together with its successors and assigns, the “*Administrative Agent*”), in favor of Invitae Corporation, a Delaware corporation (“*Grantor*”).

WHEREAS, MEDNEON, LLC a Delaware limited liability company (“MEDNEON”), executed and delivered a Trademark Security Agreement, dated as of August 18, 2021 (as may be amended, modified, restated, replaced or supplemented from time to time, the “*Trademark Security Agreement*”; capitalized terms used herein are used as defined in the Trademark Security Agreement unless otherwise specified), granting to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of MEDNEON’s right, title and interest in, to and under the Trademark Collateral, whether then existing or thereafter acquired, including all of its right, title and interest in, to and under its registered and applied-for Trademarks, which was recorded at the United States Patent and Trademark Office (“*USPTO*”) on August 23, 2021 at Reel 7401, Frame 0097.

WHEREAS, MEDNEON assigned all of its right, title and interest in, to and under the Trademark Collateral to Grantor pursuant to that certain Assignment of Trademarks, dated as of May 12, 2022, by and between MEDNEON and Grantor, which was recorded at the USPTO on May 21, 2022, at Reel 7729, Frame 0162.

WHEREAS, Grantor, as successor-in-interest to MEDNEON, has requested that the Administrative Agent hereby terminate, release and discharge fully its security interest in and liens on the portion of the Trademark Collateral listed on Schedule A attached hereto as herein provided.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. terminates, cancels, discharges, and releases all liens and security interest in any and all right, title and interest of Grantor in and to solely the portion of the Trademark Collateral listed on Schedule A attached hereto; and
2. authorizes and requests the recordation of this Termination and Release with the USPTO.




