**GRANT OF A SECURITY INTEREST --TRADEMARKS**

This Trademark Security Agreement (this “Trademark Security Agreement”) is made as of March 6, 2023, by TAOGLAS GROUP HOLDINGS LIMITED and TAOGLAS LIMITED, each a private company limited by shares incorporated under the laws of Ireland, (each a “Grantor”, and collectively, “Grantors”), in favor of BAIN CAPITAL CREDIT, LP, in its capacity as Administrative Agent for itself and the other Lender Parties (together with its successors in such capacity, “Grantee”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Grantors are the record owner of the Trademarks listed on the attached Schedule A;

WHEREAS, the Grantors have entered into a Pledge and Security Agreement, dated as of February 28, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), in favor of Grantee; and

WHEREAS, pursuant to the Security Agreement, the Grantors have granted to the Grantee for the benefit of the Lender Parties, a continuing security interest in all right, title and interest of the Grantors in, to and under the Trademarks to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

NOW, THEREFORE, as collateral security for the payment, performance and observance of all of the Secured Obligations, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby pledge and collaterally assign to the Grantee, and grant to the Grantee, for the benefit of the Lender Parties, a continuing security interest in the Trademarks to secure the prompt payment, performance and observance of the Secured Obligations.

The Grantors do hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Trademarks are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart by facsimile or electronic mail shall be equally effective as delivery of an original executed counterpart.

This Trademark Security Agreement shall be governed by, and constructed in accordance with, the laws of the State of New York.


