ASSIGNMENT OF TRADEMARK

1. Assignor does hereby sell, assign, transfer, and set over unto Assignee, its successors and assigns, all of Assignor's rights, title, and interest in and to the Trademark throughout the world, together with the goodwill of the business associated with the Trademark and the registration therefor, as well as any common law rights which may exist and are associated therewith, together with the goodwill of the business symbolized thereby and appurtenant thereto.

2. Assignor does hereby sell, assign, transfer, and set over onto Assignee, its successors, and assigns, all claims for damages by reason of past infringement or unauthorized use of the Trademark, the right to sue for and collect same for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors or assigns.

3. Assignor authorizes the Director of the United States Patent and Trademark Office and the corresponding officials of other jurisdictions, as appropriate, whose duty it is to record trademark registrations, applications and title thereto, to record the Trademark, and title thereto, as the property of Assignee, in accordance with the terms of this instrument.
