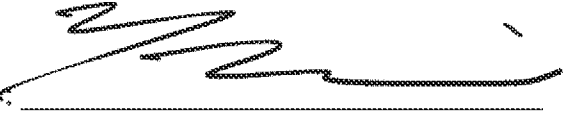
Pursuant to Section 18 of the Delaware Limited Liability Company Act, the undersigned does hereby certify:
