State of Delaware Certificate of Merger

Reference is made to that certain Agreement and Plan of Merger, dated as of the date hereof, by and between Bel-Aqua Pool Supply, LLC and Heritage Pool Supply Group, Inc. (the “**Merger Agreement**”). Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law (the “**DGCL**”) and Title 6, Section 18-209 of the Delaware Limited Liability Company Act (the “**LLCA**”), the undersigned corporation executed the following Certificate of Merger.

1. The name of the surviving corporation is Heritage Pool Supply Group, Inc., a Delaware corporation, and the name of the limited liability company being merged into this surviving corporation is Bel-Aqua Pool Supply, LLC, a Delaware limited liability company.

2. The Merger Agreement has been approved, adopted, certified, executed, and acknowledged by the surviving corporation and the merging limited liability company.

3. The name of the surviving corporation is Heritage Pool Supply Group, Inc., a Delaware corporation.

5. The Merger Agreement is on file at 7440 S. Hwy 121, McKinney, Texas 75070, the place of business of the surviving corporation.


