TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, pursuant to a separate written agreement between the parties and/or their affiliated entities (the "Agreement"), Assignor has conveyed, transferred, and assigned to Assignee the Trademarks as defined herein, and has agreed to execute and deliver this Assignment, for recording with the applicable national Trademark Office(s).

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably conveys, transfers, and assigns to Assignee, all of Assignor's right, title, and interest in and to the trademark registrations set forth on Schedule 1 hereto and all associated common law trademark rights (the "Trademarks"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks, and all rights to sue for and receive all damages occurring from past infringing uses of the Trademarks.

2. Recordation and Further Actions. Assignor hereby acknowledges that the aforementioned assignment will be recorded by Assignee. Following the date hereof, upon Assignee's reasonable request, and at Assignee's sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any exhibits, assignments, or other documents, as may be reasonably necessary to effect or perfect the assignment of the Trademarks to Assignee.

3. Terms of the Agreement. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Agreement, which contains further detail as to rights and obligations of Assignor and Assignee with respect to the Trademarks. The terms of the Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.


