CONFIRMATORY ASSIGNMENT OF TRADEMARKS

THIS CONFIRMATORY ASSIGNMENT OF TRADEMARKS ("Confirmatory Assignment"), effective as of December 6, 2022, is made by and between G.T. Bag Company, a California company having a principal place of business at 850 Lindberg Lane, Suite A, Petaluma, California 94952 ("Assignor") and Action Bag Company, an Illinois company having a principal place of business at 1001 Entry Drive, Bensenville, Illinois 60106 ("Assignee").

WITNESSETH:

WHEREAS, Assignor has adopted, has used in its business and is the owner of record for the trademarks listed in the attached Schedule A (the "Trademarks");

WHEREAS, pursuant to that certain Asset Purchase Agreement entered into on November 21, 2022, the Assignee has acquired all of Assignor's rights in and to the Trademarks and the goodwill associated therewith;

WHEREAS, Assignor and Assignee desire to memorialize the transfer of the Trademarks and their associated goodwill, *nunc pro tunc*, effective as of December 6, 2022;

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby confirms the assignment, transfer, and conveyance to Assignee of all rights, title and interest in and to (i) the Trademarks, and (ii) the goodwill of the business symbolized by the Trademarks, and (iii) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of any of the rights granted by this Confirmatory Assignment, including all claims for injunctive or declaratory relief, restitution, damages (including any statutory, enhanced or punitive damages), profits, costs (including attorney's fees) and for other monetary award, with the right to sue for and collect the same in any court of competent jurisdiction, for Assignee's sole benefit, *nunc pro tunc* as of December 6, 2022.
2. Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Confirmatory Assignment.
3. The expression "Assignor" and "Assignee" shall, where the context so admits, include their respective legal successors, representatives, and assigns.
