TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), dated as of April 1, 2022 (the "Effective Date"), is by and between Nutrition & Biosciences USA 1, LLC, a limited liability company organized under the laws of the State of Delaware, United States of America, with an address of 3490 Winton Place, Rochester, New York 14623, United States of America ("Assignor") and MC (US) 3 LLC, a limited liability company organized under the laws of the State of Delaware, United States of America, with an address of 1209 Orange Street, Wilmington, Delaware 19801, United States of America ("Assignee"), (each a "Party" and collectively, the "Parties").

WHEREAS, in connection with the sale of certain assets related to Assignor's business, Assignor has agreed to sell and assign to Assignee the trademark applications and registrations set forth on Schedule A hereto (the foregoing, including all trademarks issuing from any trademark application listed on Schedule A, collectively, the "Assigned Trademarks"); and

WHEREAS, the Parties hereto agree that the Assignor contribute, transfer, assign and convey to the Assignee all of its right, title and interest in and to the Assigned Trademarks and that the Assignee accept such contribution, transfer, assignment and conveyance of such Assigned Trademarks;

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants and agreements contained in this Assignment and for other good and valuable consideration, including the payment of one dollars (\$1.00), the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Conveyance. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Assigned Trademarks, including all goodwill associated therewith, together with all rights and remedies throughout the world (i) against past, present, and future infringement or other violation thereof, including the right to enforce the foregoing and to sue for and recover profits, other damages, injunctions and obtain other equitable relief for any and all infringements or violations thereof, whether past, present or future, (ii) to collect future royalties and other payments thereunder, (iii) to file, claim priority to, prosecute, maintain, amend, abandon, publish, keep confidential, assign, license or otherwise transfer the Assigned Trademarks; for each of the foregoing clauses (i) through (iii), to the full end of the term or terms for which the Assigned Trademarks may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor without this Assignment (the rights transferred under this Section 1 cumulatively, the "Assigned Rights").

2. Recordation; Further Assurances. Within a reasonable time following the Effective Date, Assignor shall take any and all additional actions as may be reasonably necessary to effect the transactions contemplated hereby, including Assignor's execution of individual assignment documentation for filing by Assignee with the applicable authorities of an applicable

country. Assignor authorizes Assignee and its representatives to record this Assignment of as may be desirable or necessary to support the transfer from Assignor to Assignee in connection with Assigned Rights.

3. Disclaimer of Representations and Warranties. The Parties acknowledge and agree that, except as expressly set forth in this Assignment or any other written agreement having precedence over these terms, all of the Assigned Trademarks and other assigned rights are to be provided as-is, where-is and on an "with all faults" basis and Assignee assumes all risk and liability arising from or relating to its use thereof and reliance thereon. EXCEPT AS EXPRESSLY SET FORTH IN THIS AGREEMENT OR ANY OTHER WRITTEN AGREEMENT HAVING PRECEDENCE OVER THESE TERMS, EACH PARTY MAKES NO, AND HEREBY EXPRESSLY DISCLAIMS ALL, REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE ASSIGNED TRADEMARKS AND THE OTHER ASSIGNED RIGHTS, AS TO ANY CONSENTS OR APPROVALS (INCLUDING APPROVALS FROM ANY GOVERNMENTAL ENTITIES) REQUIRED IN CONNECTION HERewith OR THEREWITH, AS TO THE VALUE OR FREEDOM FROM ANY SECURITY INTERESTS OF OR THE NON-INFRINGEMENT OR ABSENCE OF OTHER VIOLATION, DILUTION, VALIDITY OR ENFORCEABILITY OR ANY OTHER MATTER CONCERNING THE ASSIGNED TRADEMARKS.

4. Successors and Assigns. The provisions of this Assignment and the obligations and rights hereunder shall be binding upon, inure to the benefit of and be enforceable by (and against) the Parties and their respective successors and permitted transferees and assigns.

5. Counterparts. This Assignment may be executed and delivered (including by facsimile or other means of electronic transmission, such as by electronic mail in "pdf" form) in more than one counterpart, all of which shall be considered one and the same agreement, each of which when executed shall be deemed to be an original, and shall become effective when one or more such counterparts have been signed by each of the Parties and delivered to each of the Parties.

6. Title and Headings. Titles and headings to sections herein are inserted for the convenience of reference only and are not intended to be a part of or to affect the meaning or interpretation of this Assignment.


7. Governing Law. This Assignment and any dispute arising out of, in connection with or relating to this Assignment shall be governed by and construed in accordance with the Laws of the State of Delaware, without giving effect to the conflicts of laws principles thereof.
