## CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This Assignment of Security Interest in Trademarks (this "Assignment") is made as of January 6, 2023, by and from Intermediate Capital Group plc (the "Assignor") with an address at Procession House, 55 Ludgate Hill, London, EC4M 7JW to and in favor of GLAS Trust Company LLC, a New Hampshire limited liability company (the "Assignee") with an address at 3 Second Street, Suite 206, Jersey City, NJ 07311.

Recital

WHEREAS, Assignor as administrative agent under that certain Trademark Security Agreement dated as of March 9, 2021 (the "TSA") as filed with the United States Patent and Trademark Office (the "USPTO") was granted a security interest in the trademarks and the goodwill of the business in connection therewith listed on Exhibit A attached hereto (the "Trademarks") which Trademarks are registered or pending registration with the USPTO.

WHEREAS, Assignor and Assignee, among others, have entered into that certain Agent Replacement and Appointment Agreement dated as of January 5, 2023 (as amended from time to time, the "Replacement Agreement") pursuant to which Assignee has replaced Assignor as administrative agent under the TSA;

WHEREAS, Assignor has requested and Assignee has agreed to enter into this Agreement to effectuate the Replacement Agreement.

Agreement

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions: All capitalized terms not defined herein shall have the respective meaning given to them in the Replacement Agreement
2. Assignment of Security Interest:
  - (a) The Assignor hereby assigns to Assignee the security interest in all of Assignor's right, title and interest in and to, as administrative agent, the Trademarks attached hereto.
  - (b) The rights and remedies of Assignee with respect to the security interest assigned herein are without prejudice to and are in addition to those set forth in the Replacement Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment are deemed to conflict with the Replacement Agreement or the TSA, the provisions of the Replacement Agreement or the TSA, as applicable, shall govern.


