TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), effective as of September 6, 2018 (the "Effective Date"), is made by and between Westport Corporation, a New Jersey corporation ("Assignee") and Koltov, Inc., a California corporation ("Assignor"). Assignee and Assignor are sometimes referred to individually as a "Party" and collectively as the "Parties." Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Purchase Agreement (defined below).

RECITALS

WHEREAS, Assignor agreed to assign all right, title and interest in, to and under the trademark identified on Exhibit A (the "Trademark") to Assignee pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement") by and among Assignor, Assignee and the other parties thereto dated as September 6, 2018.

WHEREAS, the Trademark was contemplated to have been assigned to Assignee concurrent with execution of the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. Effective as of the Closing Date (as defined in the Purchase Agreement), Assignor hereby assigns, transfers, sells, and sets over unto Assignee all right, title, and interest, in, to, and under the said Trademark and registration therefor, together with all common law rights and the goodwill associated with said Trademark and all rights and privileges granted and secured thereby, including the right to sue and recover for any past, present or future infringement, said rights to be held and enjoyed by said Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if this Agreement and sale had not been made, together with all claims by Assignor for damages by reason of past infringement of the Trademark with the right to sue for, and collect the same for Assignee's own use and benefit, and for the use and benefit of Assignee's successors and assigns.

2. Assignor hereby authorizes the appropriate authority or authorities whose duty it is to record trademark, trademark registrations, trademark applications and title thereto, including, the United States Patent and Trademark Office, to transfer ownership and registration of the Trademark to Assignee.

3. Assignor agrees to fully cooperate with Assignee in transferring all rights to the Trademark to Assignee and to execute all lawful documents, and make all rightful oaths and declarations, which may be reasonably required, all at the sole cost and expense of Assignee, but at no remuneration to Assignee in recordable form, necessary to vest title to the Trademark and all other rights transferred and assigned by this Agreement.

4. The person signing below on behalf of Assignor has the requisite power and authority to execute, deliver and perform this Agreement.

5. This Agreement may be executed in several counterparts, each of which shall be deemed to be an original and all of which, taken together, shall be deemed to constitute one and the same Agreement. A signed copy of this Agreement delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

6. This Agreement is subject and subordinate to all of the terms and conditions of the Purchase Agreement, which is incorporated herein by reference, and in the event of any conflict or inconsistency between any term or provision hereof and any term or provision of the Purchase Agreement, the latter shall govern and control.
