RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made effective as of March 9, 2023, by and from AVENUE VENTURE OPPORTUNITIES FUND L.P., a Delaware limited partnership ("Lender"), to ASTADIA, INC., a Delaware corporation (the "Grantor") as follows:

WHEREAS, on March 17, 2021, Grantor and Lender entered into that certain Intellectual Property Security Agreement (as amended, restated or supplemented from time to time, the "IP Security Agreement") with respect to certain patents and trademarks;

WHEREAS, the IP Security Agreement was recorded by the Trademark Division of the the United States Patent and Trademark Office on March 17, 2021, at Reel 7222, Frame 0844; and

WHEREAS, all amounts owing and due under that certain loan agreement between Grantor and Lender were repaid, and all security interests granted to Lender under the IP Security Agreement have been released and terminated; and

WHEREAS, Lender wishes to further evidence its release of its interest in the patents and trademarks covered by the IP Security Agreement (the "Intellectual Property"), including, without limitation, those items listed on Appendix 1, and retransfer and reassign to Grantor all of Lender's right, title and interest in and to such Intellectual Property.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Definitions. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the IP Security Agreement.
2. Release of Security Interest. Lender hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set-off against, the Intellectual Property, including but not limited to the those items listed on Appendix 1, including any goodwill of the business symbolized by the foregoing and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns, without warranty or recourse, any and all right, title and interest Lender may have in and to the foregoing.
3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
