ASSIGNMENT OF TRADE MARKS

between

(1) New Street Brands UK Limited

and

(2) Caryn Mandabach Productions Limited

This assignment is dated and effective at the last date of signing below

Parties

(1) **New Street Brands UK Limited**, a company registered in England and Wales with company number 11897415 and whose registered office is Highdown House, 11 Highdown Road, Leamington Spa, Warwickshire, England, CV31 1XT (**NSB**);

and

(2) **Caryn Mandabach Productions Limited**, a company registered in England and Wales with company number 05379177 and whose registered office is at 39a Berwick Street, London, W1F 8RU (**CMP**);

BACKGROUND

- (A) NSB is the registered proprietor of the Trade Marks (as defined below).
- (B) By the Main Agreement (as defined below) NSB agreed to assign the Trade Marks to CMP.

Agreed terms

1. Interpretation

The following definitions and rules of interpretation apply in this agreement.

1.1 Definitions:

Main Agreement: the confidential agreement dated on or around the date of this assignment, between NSB, CMP and others.

Trade Marks: the registered trade marks and applications for trade marks short particulars of which are set out in Schedule 1.

1.2 The Schedule forms part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedule.

1.3 Terms defined in the Main Agreement have the same meaning where used in this agreement, except where stated otherwise.

2. Assignment

Pursuant to the Main Agreement, and in consideration of the sum of £1.00 (the receipt and sufficiency of which NSB acknowledges), NSB hereby assigns absolutely to CMP all such legal and beneficial right, title and interest as NSB has in and to the Trade Marks, including all statutory and common law rights in and goodwill attaching to the respective Trade Marks, and the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action and to rely on the respective Trade Marks pursuant to any cause of action arising from

ownership, of any of the respective Trade Marks, whether occurring before, on or after the date of this agreement anywhere in the World.

3. General

- 3.1 This agreement may be executed in any number of counterparts, including execution by electronic means, each of which shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.
- 3.2 Transmission of an executed counterpart of this agreement by email (in PDF, JPEG or other agreed format) shall take effect as an executed counterpart of this agreement.
- 3.3 The agreement is governed by the laws of England and Wales. The Parties submit to the exclusive jurisdiction of the English courts in relation to any dispute arising out of or in connection with this agreement.
