**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of March 14, 2023 (this “Release”) is made by Twin Brook Capital Partners, LLC, acting in its capacity as agent (in such capacity, the “Agent”) under that certain Trademark Security Agreement, dated as of July 9, 2020 (the “Trademark Security Agreement”) by Foundation Systems of Michigan, LLC and Gutter Systems of Michigan, LLC (each, a “Grantor” and together, the “Grantors”) in favor of the Agent.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on July 10, 2020 at reel 6996, frame 0598, each Grantor granted to the Agent a continuing security interest in all of such Grantor’s right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule 1 attached hereto; and

WHEREAS, the Grantors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and reassignment of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral and (d) reassign to each Grantor any and all right, title and interest that it may have in the Trademark Collateral owned by such Grantor.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
