Kintent, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “*General Corporation Law*”), does hereby certify:

FIRST: That the name of this corporation is Kintent, Inc. (the “*Corporation*”).

SECOND: The Corporation was originally incorporated pursuant to the General Corporation Law on March 30, 2020.
