**TRADEMARK ASSIGNMENT AGREEMENT**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer unto Assignee the entire right, title, and interest in and to the Trademarks, together with the goodwill of the business in connection with which the Trademarks are used.

2. Assignor shall do all acts and execute all documents that may be reasonably required by Assignee in order to effect the assignment of the Trademarks.


