INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (“Agreement”) is entered into as of March 14, 2023, by and among Wintrust Bank, National Association, a national banking association, in its capacity as Administrative Agent for the Lenders from time to time party to the Loan Agreement (defined below) (in such capacity, “Administrative Agent”), F&S IP OWNER LLC, a Delaware limited liability company, and each additional borrower from time to time party hereto (each a “Borrower”, and collectively the “Borrowers”).

RECITALS

The Lenders have agreed to make certain advances of money and to extend certain financial accommodations to Borrowers under that certain Loan and Security Agreement by and among the Borrowers, the other parties from time to time party thereto, the Lenders party from time to time thereto, and Administrative Agent, dated as of even date herewith (as amended, supplemented or otherwise modified from time to time, the “Loan Agreement”). Pursuant to the terms of the Loan Agreement, each of the Borrowers has granted to the Administrative Agent a security interest in the Borrower’s personal property constituting Collateral. Capitalized terms used herein are used as defined in the Loan Agreement.

NOW, THEREFORE, Borrowers and the Administrative Agent agree as follows:

AGREEMENT

To secure its obligations under the Loan Agreement and under any other agreement now existing or hereafter arising between or among the Borrowers, the Lenders, and any other Loan Party, each of the Borrowers grants to the Administrative Agent, a security interest in all of the Borrower’s right, title and interest in, its Intellectual Property (including those certain copyrights, patents and trademarks set forth on Exhibit A attached hereto), all goodwill of the business associated therewith, all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements thereof, all rights corresponding thereto throughout the world, and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof. Notwithstanding the foregoing, the grant herein shall not extend to any Excluded Property.

Borrowers represent and warrant that Exhibit A attached hereto sets forth any and all Intellectual Property rights in connection to which such Borrower has registered or filed an application with the United States Patent and Trademark Office, the United States Copyright Office, or any corresponding foreign or international intellectual property office, body, or agency.

Capitalized terms used in this Agreement shall have the definitions that are assigned to them in the Loan Agreement. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Administrative Agent pursuant to the Loan Agreement. Each Borrower and Administrative Agent hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Intellectual Property made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any conflict or inconsistency between the terms of the Loan Agreement and the terms of this Agreement, the terms of the Loan Agreement shall govern. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.

This Agreement and any claim, controversy, dispute, or cause of action based upon, arising out of,




