**Hive-down of the business operations of Bruker Optik Holding  
GmbH to Bruker Optics GmbH & Co. KG**

March 25, 2022

Dear Madams and Sirs,

In the above matter, you have requested a notarial certification of the structural measures at Bruker Optik Holding GmbH (formerly Bruker Optik GmbH) (Mannheim Local Court, HRB 362608) which took effect on December 1, 2021, in order to be able to demonstrate, in particular to customers and suppliers, as well as to authorities and tender authorities of Bruker Optik Holding GmbH (formerly Bruker Optik GmbH), that all assets (including, but not limited to, all real property and operating facilities, employees, licenses, customer, supplier and other contractual relationships) of the aforementioned company were transferred with retroactive economic effect as of January 1, 2021 to Bruker Optics GmbH & Co. KG (Mannheim Local Court, HRA 710333).

To this end, I hereby grant the following notarial certification:

I hereby certify, having knowledge of the hive-down and takeover agreement between Bruker Optik Holding GmbH (formerly Bruker Optik GmbH) and Bruker Optics GmbH & Co. KG dated October 29, 2021 (deed no. 119/2021 of the public notary Dr. Jochen N. Schlotter with

office in Frankfurt/Main) as well as on the basis of inspection on March 25, 2022 in the electronic Commercial Registers at the Local Court of Mannheim, as specified in more detail below, as follows:

**1. Local Court Mannheim**

**HRB 362608**

Bruker Optik Holding GmbH (formerly Bruker Optik GmbH) has hived-down all assets of its business (including, but not limited to, all real estate and business premises, employees, industrial property rights, licenses, customer and supplier relationships and other contractual relationships) to Bruker Optics GmbH & Co. KG (Mannheim Local Court, HRA 710333) by way of a notarial hive-down and transfer agreement dated October 29, 2021 (deed no. 119/2021 of the public notary Dr. Jochen N. Schlotter with office in Frankfurt/Main). The hive-down became legally effective on December 1, 2021.

**2. Local Court Mannheim**

**HRA 710333**

Until September 14, 2021, the sole limited partner of Bruker Optics GmbH & Co. KG (formerly Youco B21-H255 Vorrats-GmbH & Co. KG) was Youco24 Vorratsgesellschaften GmbH, registered with the Commercial Register of the Local Court of Cologne under HRB 101320. By way of an agreement dated September 14, 2021, a copy of which is available to me, Youco24 Vorratsgesellschaften GmbH sold its limited share in Bruker Optics GmbH & Co. KG (formerly Youco B21-H255 Vorrats-GmbH & Co. KG, formerly registered with the Commercial Register of the Local Court of Charlottenburg under HRA 58608) to Bruker Optik Holding GmbH (formerly Bruker Optik GmbH). The limited share has been assigned to Bruker Optik Holding GmbH (formerly Bruker Optik GmbH) with immediate effect in rem by way of special legal succession. The withdrawal of Youco24 Vorratsgesellschaften GmbH by way of special legal succession was entered in the Commercial Register of Bruker Optics GmbH & Co. KG on October 12, 2021.

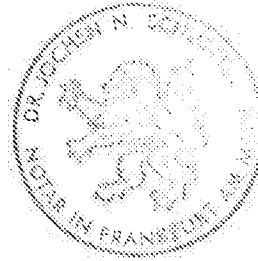
The sole general partner of Bruker Optics GmbH & Co. KG is Bruker Optics Verwaltungs GmbH, registered with the Commercial Register of the Local Court of Mannheim under HRB 741506 HB (formerly: Youco B21-H183 Vorrats-GmbH, formerly registered with the Commercial Register of the Local Court of Charlottenburg under HRB 227115 B). Also, with the same agreement dated September 14, 2021, a copy of which is available to me, Bruker Optik Holding GmbH (formerly Bruker Optik GmbH) acquired all shares in Bruker Optics Verwaltungs GmbH. The new list of shareholders of Bruker Optics Verwaltungs

GmbH, which shows Bruker Optik GmbH (now Bruker Optik Holding GmbH) as the sole shareholder, was registered with the competent commercial register on October 8, 2021.

It follows from the circumstances certified under 1. and 2. above that with the coming into effect of the measures described above, all assets of Bruker Optik Holding GmbH (formerly Bruker Optik GmbH) described under 1. and 2. above and all contractual relationships in connection therewith have been transferred to Bruker Optics GmbH & Co. KG with its registered office in Mannheim.
