## **RELEASE OF PATENT, TRADEMARK AND COPYRIGHT SECURITY INTEREST**

This Release of Patent, Trademark and Copyright Security Interest (“Release”) is made effective as of September 15, 2021 by TRUIST BANK, a North Carolina banking corporation (the “Lender”), and GREAT DAY IMPROVEMENTS, LLC, a Delaware limited liability company (the “Pledgor”), as follows:

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement dated as of November 18, 2020 (the “Patent and Trademark Security Agreement”) and that certain Copyright Security Agreement dated as of November 18, 2020 (the “Copyright Security Agreement”), the Pledgor granted to the Lender a security interest in certain intellectual property as security for loans and other obligations;

WHEREAS, the Patent and Trademark Security Agreement was recorded in the United States Patent and Trademark Office on November 20, 2020, at Reel 054433 / Frame 0774 (Patents) and at Reel 007112 / Frame 0641 (Trademarks);

WHEREAS, pursuant to the Patent and Trademark Security Agreement, Copyright Security Agreement and other documents identified above (“Other Documents”), the Pledgor granted to the Lender a security interest in the entire right, title and interest of the Pledgor in and to all of the Pledgor’s Patent and Trademark Collateral and Copyright Collateral, (as such terms are defined in the Patent and Trademark Security Agreement, Copyright Security Agreement and Other Documents) including the trademarks, patents and copyrights set forth in Schedule A hereto;

WHEREAS, the Lender wishes to release its security interest in all of Pledgor’s Patent and Trademark Collateral and Copyright Collateral including the trademarks, patents and copyrights set forth in Schedule A hereto .

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Release. The Lender hereby, without warranty as to status of title or priority of the encumbrances being hereby released, releases, discharges, terminates and cancels all right, title and interest in and to the Patent and Trademark Collateral and Copyright Collateral and all Patents, Trademarks and Copyrights of Pledgor, including, without limitation, any security interest it may have in such Patent and Trademark Collateral and Copyright Collateral and Patents, Trademarks and Copyrights and the goodwill of the business connected with the use of, and symbolized by, such Patents, Trademarks and Copyrights, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse solely as to the Pledgor.

2. Termination. The Lender, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, hereby terminates and cancels the (i) Patent and Trademark Security Agreement, and (ii) Copyright Security Agreement.


3. Further Assurances. At the request and expense of the Pledgor, the Lender hereby agrees to perform all other and further acts, and provide to the Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor to retransfer and reassign any and all right, title and interest it may have in the above-referenced Patent and Trademark

Collateral and Copyright Collateral and Patents, Trademarks and Copyrights without recourse to the Pledgor.
