**RELEASE AND DISCHARGE OF  
TRADEMARK SECURITY**

TO: Cognota, Inc. (formerly Get Synapse, Inc.) ("**Grantor**")

Box 61, Toronto, Ontario, M5J 2J2, hereby releases, terminates and discharges all right, title and interest, including all security interest, in and to the Intellectual Property Collateral (as defined in the Comerica Loan Agreement) listed on Schedule "A" (the "**Released Trademarks**"). The Secured Party hereby transfers and assigns to the Grantor any right, title or interest of any kind or nature it may have in, to or under the Released Trademarks, without representation or warranty.

Secured Party authorizes and directs the Canadian Intellectual Property Office ("CIPO") and the United States Patent and Trademark Office ("**USPTO**") to record this Release and Discharge of Trademark Security and to discharge and remove the lien filings in favour of Secured Party with CIPO and the USPTO against the Released Trademarks, Secured Party authorizes and directs Grantor and counsel for Grantor to file, or cause to be filed, this Release and Discharge of Trademark Security with CIPO and the USPTO.

This Release and Discharge of Trademark Security shall be binding upon the Secured Party and its legal representatives, assigns and successors.
