TRADEMARK ASSIGNMENT

WHEREAS, SNAK CLUB, LLC, a Delaware Limited Liability Company with an address of 5560 E. NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged, in connection with the transfer of assets to which the marks pertain, Assignor does hereby sell, assign, transfer and set over to Assignee all its right, title and interest in, to and under the Mark and applications or registrations therefor, together with the goodwill of the business symbolized by the Mark, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.
