Pursuant to §251 of the Delaware General Corporation Law ("DGCL"), it is hereby certified that:

1. The constituent corporations participating in the merger are:
 - (a) MicroVention, Inc., which is incorporated under the laws of the State of Delaware ("MicroVention"); and
 - (b) Sequent Medical, Inc., which is incorporated under the laws of the State of Delaware ("Sequent").
2. An Agreement of Merger, dated as of March 9, 2023 (the "Merger Agreement"), has been approved, adopted, executed, and acknowledged by each of MicroVention and Sequent (each a "Constituent Corporation" and, collectively, the "Constituent Corporations") in accordance with the provisions of §251 of the DGCL.
3. The Merger Agreement has been approved and adopted by the sole stockholder of each of the Constituent Corporations in accordance with the provisions of §228 of the DGCL.
4. The corporation surviving the merger after the filing of this Certificate of Merger shall be MicroVention (the "Surviving Corporation"). The Surviving Corporation will continue its existence after the filing of this Certificate of Merger pursuant to the applicable provisions of the DGCL. The certificate of incorporation of the Surviving Corporation shall continue to be its certificate of incorporation immediately following the merger.
5. The executed Merger Agreement is on file at the offices of the Surviving Corporation, the address of which is 35 Enterprise, Aliso Viejo, CA 92656.
6. A copy of the executed Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any of the Constituent Corporations.
7. The merger shall become effective upon filing of this Certificate of Merger.
