TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this “Termination and Release”) is made as of the 13th of March, 2023, by CITY NATIONAL BANK, as the lead arranger and administrative agent for the Lenders (in such capacity as administrative agent, together with its successors and assigns in such capacity, the “Agent”) to FRESHPET, INC., a Delaware corporation (the “Debtor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Loan Agreement (defined below) or the Trademark Security Agreement (defined below), as applicable.

W I T N E S S E T H

WHEREAS, pursuant to that certain Sixth Amended and Restated Loan and Security Agreement, dated as of February 19, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), by the Debtor in favor of the Agent, the Debtor executed that certain Fifth Amended and Restated Trademark Security Agreement, dated as of February 19, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on February 19, 2021, at Trademark Reel 7197 Frame 0696, pursuant to which the Debtor granted a security interest to the Agent, for the benefit of the Lenders, in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule I hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Debtor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. the Agent hereby releases its security interest in all of Debtor’s right, title and interest in and to the Trademark Collateral, including those trademarks set forth on Schedule I.
2. if and to the extent that Agent has acquired any right, title or interest in or to any of the Trademark Collateral, the Agent hereby reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Agent, any and all of the Agent’s right, title, and interest in and to the Trademark Collateral, along with any goodwill in the Trademarks that the Agent may have acquired.
