


ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (this "Agreement") is made and entered into as of September 15, 2021, by and among (i) FULLER INDUSTRIES, LLC, a Kansas limited liability company ("Seller"), (ii) FULLER PROPERTIES, LLC, a Kansas limited liability company ("Fuller Properties"),

 (collectively, the "Controlling Members" and, together with Fuller Properties and Seller, the "Seller Parties" and each individually, a "Seller Party"), and (iv) FULLER INDUSTRIES INC., a Delaware corporation ("Buyer"). The Seller Parties and Buyer are sometimes individually referred to in this Agreement as a "Party" and collectively as the "Parties."

  
WHEREAS, CleanGenic, LLC, a Kansas limited liability company ("CleanGenic"), is a wholly-owned Subsidiary of Seller, without any business, assets or properties;

  
NOW, THEREFORE, in consideration of the foregoing and the respective representations, mutual covenants, agreements and understandings contained herein and intending to be legally bound, the Parties hereby agree as follows:

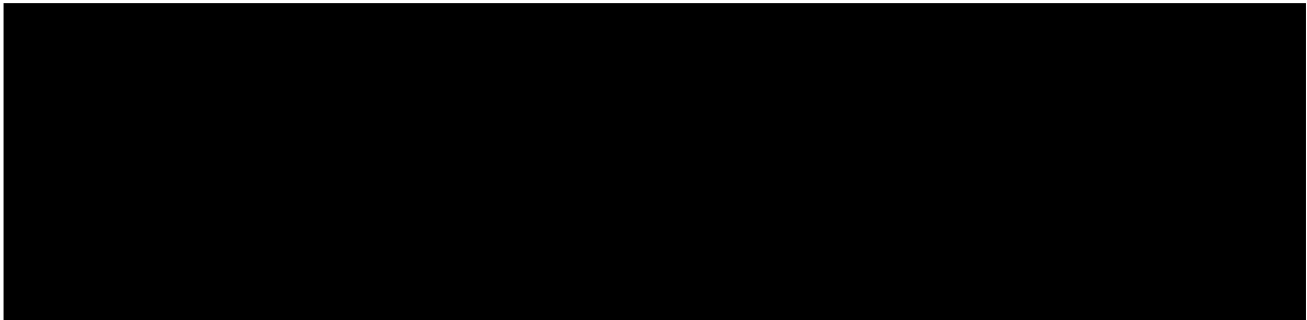

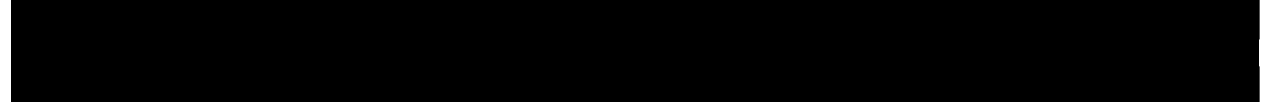

2.1 Basic Transaction.

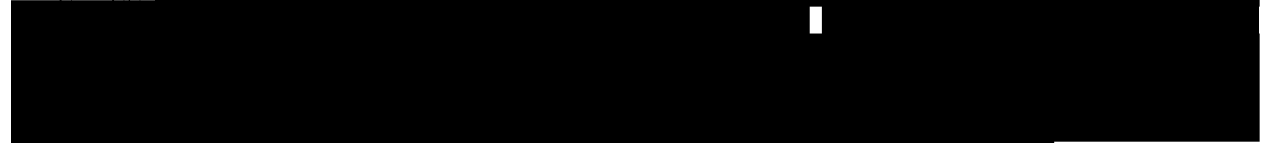

On the terms and subject to the conditions set forth in this Agreement, at the Closing, Buyer (and/or its assignee) shall purchase from Seller or its Affiliates, and Seller shall (or shall cause its Affiliates to) sell, convey, assign, transfer and deliver to Buyer (and/or its assignee), all assets, properties, rights, titles and interests of every kind and nature owned, licensed or leased by Seller or its Affiliates (including indirect and other forms of beneficial ownership) as of the Closing Date (except for the Excluded Assets), which are related to, or are used or held for use in connection with, the Business, whether tangible or intangible, real or personal and wherever located and by whomever possessed (the "Purchased Assets"), free and clear of all Liens (other than Permitted Liens), including the following:



(iv) all of the following which are owned by, issued to, or licensed to Seller, along with all of Seller's interest in income, royalties, damages and payments accrued, due or payable as of the Closing Date or thereafter (including damages and payments for past, present or future infringements or misappropriations thereof, the right to sue and recover for past infringements or misappropriations thereof and any and all corresponding rights that, now or hereafter, may be secured throughout the world):



trademarks, trade names, service marks and trade dress (including any and all rights in the names "FULLER," "FULLER INDUSTRIES," "FULLER PLASTICS," "FULLER PROPERTIES," and "CLEANGENIC"), together with all goodwill associated therewith, and all translations, adaptations, derivations and combinations of the foregoing (and all logos related to the foregoing);



(collectively, the "Proprietary Rights");



7.8 Governing Law.

(a) This Agreement and all disputes or controversies arising out of or relating to this Agreement or the transactions contemplated hereby shall be governed by, and construed in accordance with, the internal Laws of the State of Kansas, without regard to the Laws of any other jurisdiction that might be applied because of the conflicts of Laws principles of the State of Kansas.



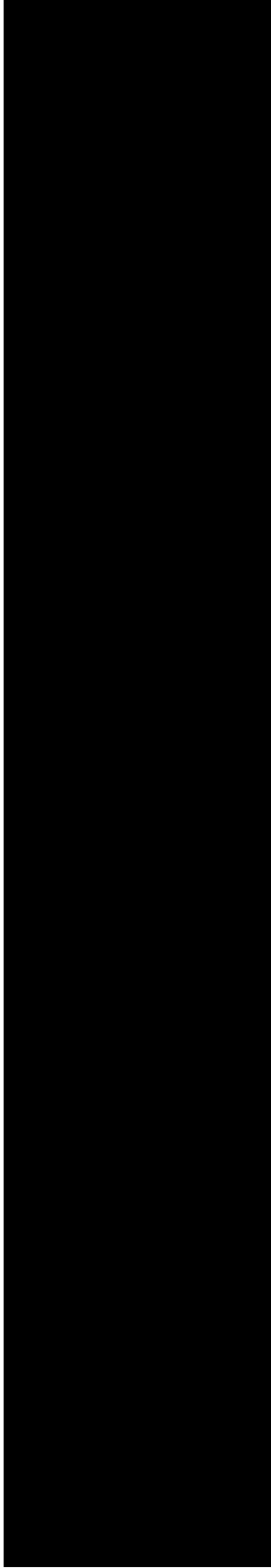

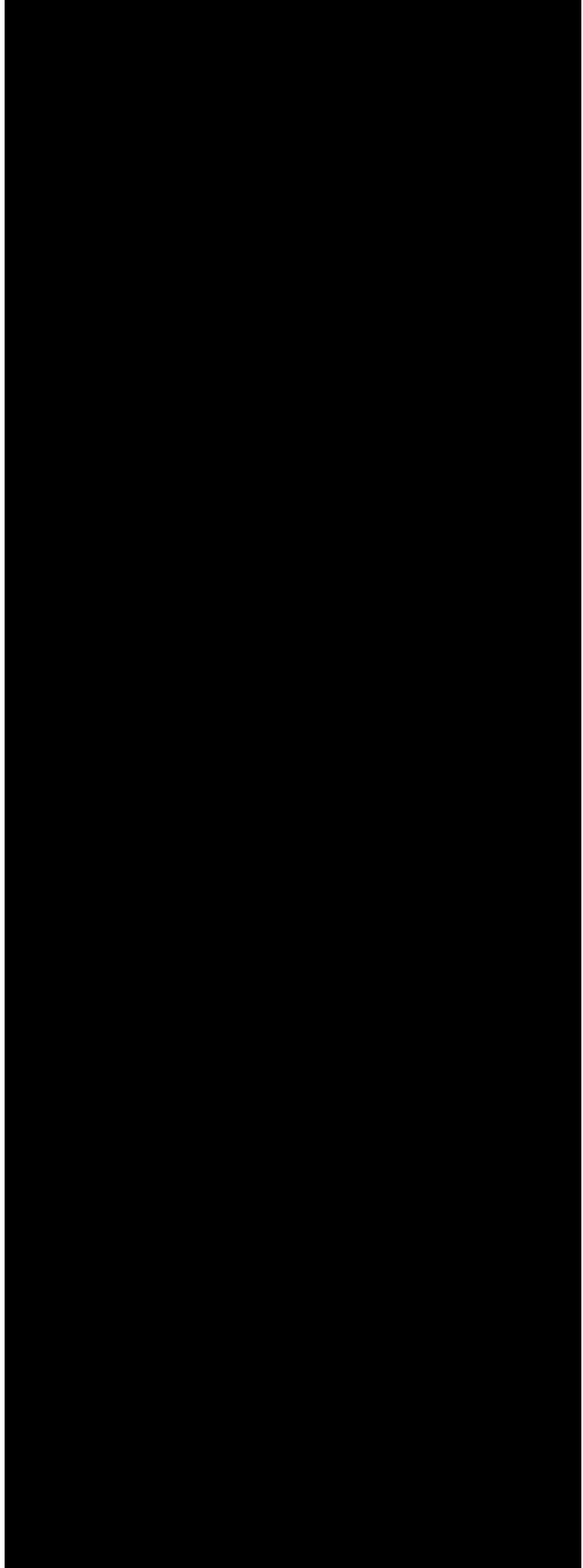
