TRADEMARK ASSIGNMENT

American Multi-Cinema, Inc., a Missouri Corporation with a principal place of business at One AMC way, 11500 Ash St., Leawood, Kansas, United States, 66211 (“ASSIGNOR”) owns all right, title and interest in and to the trademark(s) (the “Marks”) as identified in Exhibit A, together with the goodwill of the business symbolized thereby.

Cineplex Entertainment LP, a limited partnership pursuant to the laws of Manitoba, with a principal place of business at 1303 Yonge Street, Toronto, Ontario M4T 2Y9 (“ASSIGNEE”) desires to acquire and accept all right, title, and interest in and to the Marks and all associated goodwill.

For ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, ASSIGNOR assigns to ASSIGNEE all right, title, and interest in and to the Marks, together with:

- a. all associated goodwill;
- b. all common law rights in the Marks;
- c. all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and
- d. all rights to sue for past, present and future infringements or misappropriations of the Marks.

ASSIGNEE shall have full and unrestricted right to use, license, assign, offer to sell, sell, encumber, secure, loan, and otherwise exploit the Marks to its fullest extent anywhere in the world, without the consent of and without accounting to ASSIGNOR or any third party, and without sharing, in whole or in part, with ASSIGNOR or any third party, the revenue or profits generated by or through such use, license, assignment, sale, encumbrance, loan, or other exploitation of the Marks.

At ASSIGNEE’S expense, ASSIGNOR agrees to sign all other documents necessary to give effect to the foregoing or to establish that the ASSIGNOR does not have any other right, title, and interest in and to the Marks.

ASSIGNOR and ASSIGNEE agree that this document may be executed in any number of counterparts, each of which shall be deemed to be an original and which together shall constitute one and the same assignment.

This Trademark Assignment will be governed by and construed in accordance with the laws of the State of Kansas. The parties hereby expressly submit and consent to the exclusive jurisdiction and exclusive venue of the courts of competent jurisdiction of the courts in Johnson County, Kansas, including federal courts.
