**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of March 16, 2023 (“Release”), is made by CIBC BANK USA (“CIBC”), in favor of WAYUP, INC., a Delaware corporation (“Grantor”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of July 13, 2021, by and among Grantor and CIBC (the “Security Agreement”), Grantor granted to CIBC a continuing security interest in all of Grantor’s right, title, and interest in and to certain intellectual property assets, including, without limitation, the trademark registrations and applications set forth on Exhibit A attached hereto (the “Trademark Collateral”); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on July 14, 2021, at Reel/Frame 7354/0497 with respect to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CIBC agrees as follows:


SECTION 1. Termination and Release. CIBC hereby terminates the Security Agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Trademark Collateral thereunder.

SECTION 2. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
