RELEASE OF SECURITY INTERESTS IN TRADEMARKS



Grantee agrees to execute and deliver to the Grantor, at the Grantor’s expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Trademarks which had been granted under the Intellectual Property Security Agreement.
