INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “**Agreement**”) is made as of February 9, 2022 by and between HUSSEY SEATING COMPANY, a Maine corporation (“**Seller**”), and SPECSEATS INT’L CORP., a California corporation (“**Purchaser**”).

RECITALS

A. The Seller and the Purchaser are entering into that certain Asset Purchase Agreement, dated as of the date hereof (the “**Purchase Agreement**”), whereby the Seller is selling certain assets of Seller to the Purchaser. Capitalized terms used herein but not defined shall have the meanings set forth in the Purchase Agreement.

B. This Agreement is being executed and delivered pursuant to Section 6.1(a) of the Purchase Agreement.

AGREEMENT

NOW, THEREFORE, in consideration of the Purchase Price, the premises and the representations, warranties, covenants and agreements contained herein, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the Seller agrees as follows:

1. Transfer of Intellectual Property. The Seller hereby grants, sells, assigns, conveys, transfers and delivers Seller’s trade name, “Clarin Seating”, “Boxxseats” and the other Intellectual Property relating to the Business set forth on Exhibit A attached hereto (collectively, the “**IP Assets**”) and all of the Seller’s right, title and interest therein and thereto unto the Purchaser and its successors and assigns. Without limiting the foregoing, the Seller grants, sells, assigns, conveys, transfers and delivers to the Purchaser, the Seller’s rights, titles and interests (legal, equitable, use and otherwise) in and to any and all: (a) rights to file and register the IP Assets in the Purchaser’s name with any Government Entity; (b) rights to record the transfers made under this Agreement in the United States Patent and Trademark Office and in any other public offices of any Government Entities; (c) rights to sue for, collect and retain damages predicated on present or future infringements of the IP Assets, as well as all other claims and rights to damages associated with the IP Assets, whether predicated on past, present or future actions or omissions, and whether or not currently known or unknown; and (d) goodwill associated with the IP Assets. The Seller’s assignment of the IP Assets to the Purchaser under this Agreement constitutes a complete, absolute and exclusive transfer of all rights (legal, equitable, use and otherwise) of the Seller in the IP Assets, whether currently existing or arising or recognized in the future. Except with respect to the limited license set forth in that certain Transition Services Agreement of even date herewith between the Seller and the Purchaser, the Seller does not reserve or retain any rights, titles or interests in the IP Assets.

2. Further Assurances. The Parties will, from time to time, execute and deliver, or cause to be executed and delivered, such additional instruments, notices, releases, certificates, powers of attorney, assurances, bills of sale, and other documents and do all such further acts, assignments, transfers and other things, as may reasonably be requested by either Party to more completely transfer the IP Assets and for the effective confirmation, consummation and particularization of this Agreement in each case at Purchaser’s sole cost and expense and to the extent consistent with the terms and provisions of the Purchase Agreement.

3. Additional Rights and Obligations of the Parties. The Parties hereby agree and acknowledge that this Agreement is being entered into and delivered pursuant to and subject to the terms and conditions set forth in the Purchase Agreement, that additional rights and obligations of the Parties are

expressly provided for therein, and that the execution and delivery of this Agreement shall not impair, amend, or diminish any of the rights or obligations of the Parties to the Purchase Agreement, as set forth therein.

4. Conflicts. This Agreement is subject in all events to the terms and conditions of the Purchase Agreement. In the event of a conflict or inconsistency between this Agreement and the Purchase Agreement, the terms of the Purchase Agreement shall prevail.

5. Governing Law. This Agreement shall be governed by and construed exclusively in accordance with the laws of the State of Delaware without regard to choice of law provisions.

6. Binding Effect. This Agreement shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

7. Electronic Delivery. This Agreement, to the extent signed and delivered by means of e-mail or a facsimile machine or other electronic delivery, shall be treated in all respects as an original Contract and shall be considered to have the same binding effect as if it were the original signed version thereof.


